**MINUTES**

The Meeting was called to order by Chairman Hamilton and the roll was called by Beth Dunham; Chairman Hamilton-present, Commissioner McNutt-present, Commissioner Reeves-present, Commissioner Rudawsky-present, Commissioner Satz-absent, Commissioner Tucci-present, Commissioner Asfaw-present, and Commissioner Sommers-present. A quorum being found the meeting began. Chairman Hamilton made a motion to approve the October 7, 2014 minutes, seconded by Commissioner Tucci. There was no discussion by the board and vote was taken; Chairman Hamilton-yes, Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes and Commissioner Sommers-yes, the minutes were adopted.

**NEW BUSINESS**

Following the Director's report, the following items were discussed and voted upon by the Commission:

- December 9, 2014 at 11:00a.m. was set as the next regular meeting of the Commission. (approved by consensus, no vote taken)
- **CCN Hearing for XL Transportation – Premium Sedan Class.** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. Upon a motion made to accept the staff recommendation and approve the CCN by Chairman Hamilton, and seconded by Commissioner Tucci, discussion ensued. Chairman Hamilton then called the question and vote was taken and the motion was approved; Chairman Hamilton-yes, Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-abstain, Commissioner Tucci-yes, Commissioner Asfaw-yes, and Commissioner Sommers-yes.
- **CCN Hearing for Elite Transportation – Premium Sedan Class.** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. Upon a motion made to accept the staff recommendation and approve the CCN by Chairman Hamilton, and seconded by Commissioner Reeves, discussion ensued. - **CCN Hearing for Arch Medical Transportation – NEMT Sedan Class.** The Deputy Director presented the CCN application to the board explaining the application was the sale of ownership from Ace Transportation to Arch Medical Transportation and the staff recommended the sale of ownership for approval. Upon a motion made to accept the staff recommendation and approve the CCN by Chairman Hamilton, and seconded by Commissioner Tucci, discussion ensued. Chairman Hamilton then called the question and vote was taken and the motion was approved; Chairman Hamilton-yes, Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, and Commissioner Sommers-yes.
- **CCN Hearing for Jack Rabbit Transportation – Airport shuttle Class** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. Upon a motion made to accept the staff recommendation and approve the CCN by Chairman Hamilton, and seconded by Commissioner Reeves, discussion ensued. Chairman Hamilton then called the question and vote was taken and the motion was approved; Chairman Hamilton-yes, Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, and Commissioner Sommers-yes.

- **John Bardgett & Associates Services Agreement-** Chairman Hamilton presented the board with the amendment to the existing MTC and JBA agreement to provide legislative consulting services. Upon a motion made to accept the service agreement by Chairman Hamilton and seconded by Commissioner McNutt, with no discussion Chairman Hamilton called the question and vote was taken and the motion was approved; Chairman Hamilton-yes, Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, and Commissioner Sommers-yes.
- **Appointment of Committee's-** Chairman Hamilton made a motion asking the authority of the board to allow him to appoint Commissioners to be Chairman of committee's to focus on the rate structure, IT infrastructure, and communications of the Commission. The motion was seconded by Commissioner McNutt, with no discussion Chairman Hamilton called the question and vote was taken and the motion was approved; Chairman Hamilton-yes, Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, and Commissioner Sommers-yes.
