**MINUTES**

The Meeting was called to order by Commissioner Reeves and the roll was called by Bob Oldani; Chairman Hamilton-absent, Commissioner McNutt-present, Commissioner Reeves-present, Commissioner Rudawsky-present, Commissioner Satz-present, Commissioner Tucci-present, Commissioner Asfaw-present, and Commissioner Sommers-present. A quorum being found the meeting began.

**NEW BUSINESS**

The following items were discussed and voted upon by the Commission:

- **Code Revision**—The legal counsel presented a code revision amending Chapter 1, section 101 A.43 (Definition of Non-Emergency Medical Transport Vehicles) and Chapter 6, section 606 G and H, (Special Requirements for Non-Emergency Medical Transport Vehicles). Commissioner Tucci made a motion, seconded by Commissioner Satz. There being no discussion, Commissioner Reeves called the question and a vote was taken: Commissioner McNutt-abstain, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Satz-yes, Commissioner Tucci-yes, Commissioner Asfaw-abstain, Commissioner Sommers-yes. The amendment passed.
- **CCN Hearing for Airport Best Limo Service 2 – Premium Sedan Class.** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. A motion was made to accept the staff recommendation and approve the CCN by Commissioner Tucci, seconded by Commissioner Satz. There was no discussion. Commissioner Reeves then called the question, a vote was taken and the motion was approved; Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Satz-yes, Commissioner Tucci-yes, Commissioner Asfaw-abstain and Commissioner Sommers-yes.
- **CCN Hearing for AMJ Transportation, LLC – Premium Sedan Class.** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. A motion was made to accept the staff recommendation and approve the CCN by Commissioner Tucci and seconded by Commissioner Satz. There was no discussion. Commissioner Reeves then called the question, a vote was taken and the motion was approved; Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-abstain, Commissioner Satz-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, and Commissioner Sommers-yes.
- **CCN Hearing for Arch Towne Transportation, LLC – Premium Sedan Class.** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. - **CCN Hearing for MRCR Enterprises, LLC (DBA) Exceed Limo – Premium Sedan Class.** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. A motion was made to accept the staff recommendation and approve the CCN by Commissioner Tucci and seconded by Commissioner Rudawsky. There was no discussion. Commissioner Reeves then called the question, a vote was taken and the motion was approved; Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Satz-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes and Commissioner Sommers-yes.
- **CCN Hearing for Exclusive Transportation, LLC – Premium Sedan Class.** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. A motion was made to accept the staff recommendation and approve the CCN by Commissioner Tucci and seconded by Commissioner Satz. There was no discussion. Commissioner Reeves then called the question and vote was taken and the motion was approved; Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Satz-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, and Commissioner Sommers-yes.
- **CCN Hearing for White Knight Limousine, Inc. – Premium Sedan Class.** The Deputy Director presented the CCN application to the board with a staff recommendation of approval. A motion was made to accept the staff recommendation and approve the CCN by Commissioner Satz and seconded by Commissioner Sommers. There was no discussion. Commissioner Reeves then called the question, a vote was taken and the motion was approved; Commissioner McNutt-yes, Commissioner Reeves-yes, Commissioner Rudawsky-yes, Commissioner Satz-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, and Commissioner Sommers-yes.

Following the CCN approvals, Commissioner McNutt recommended that the staff remind the Premium Sedan CCN holders of their responsibilities to abide by the Vehicle for Hire Code, specifically regarding the solicitation of trips. Director Klein acknowledged the recommendation.
