**AGENDA & MINUTES**

A quorum being found the meeting began.

The motion was seconded by Commissioner Gilbert, vote was taken and the provisional CCN was approved; Commissioner McNutt-abstain, Commissioner Satz-yes, Commissioner Asfaw-yes, Commissioner Osho-yes, Commissioner-Rudawsky, and Commissioner Gilbert-yes.
