AGENDA & MINUTES

- The Meeting was called to order by Chairman McNutt at 10:14 AM and the roll was called by Director Ronald Klein: Commissioner Satz-present, Commissioner Asfaw-absent, Commissioner Osho-present, Commissioner Rudawsky-present, Commissioner Vianello-present and Chairman McNutt – present. A quorum being found the meeting began.

Chairman McNutt said that he sent a letter to both City and County asking to fill the seats on the board and for the money. Commissioner Satz said that he was at the airport the night before and at 10:30 PM everything was already closed at the airport.
